 - No Governance => Poor Data Quality=> Company Liability








- Key Balance




- Keys For Success
 - Easy & Fun UI
 - Cursor Jumps To Appropriate Field
 - Automate Data Entry When Possible
 - Faster Data Entry
 - Less Errors = Better Quality
 - Avoid Freeform Fields When Possible
 - Pull Down Fields
 - Lookup Fields
 - Etc.
 - Show Data Quality Measurements
 - Important To Show Data Value
 - Small Animated gifs Or Images Are Fun & Powerful
 - » Simple Example: Thumbs Up / Down Or Stop Light
 - » Advanced Example: Color Changing Pie Chart With Quality Percentage






- Keys For Success Continued
 - Data Goals
 - Create Goals That Are
 - Achievable
 - Trackable
 - Research Data Providers
 - Some Data Such As Customer Demographics Can Often Be Purchased
 - Set Up Regularly Scheduled Data Cleansings
 - Conform Data To Standards
 - Ex: Phone Number Formatting
 - Ex: Use Of Abbreviations (Saint Joseph Hospital vs St Joseph Hospital)
 - Conformity Allows For Much Better Data Searching
 - Deduping
 - Reduce Deduping Needs By Implementing Preventative Solutions
 - » Ex: During Record Addition, Automatically Search For Duplicates & Warn User If Any Are Found
 - Populate Missing Data
 - Use Data Quality Measurements
 - » Typically Drill Into Data From Dashboards
 - Use Tools To Compare With Trusted Data Sources





- Keys For Success Continued
 - Flexibility
 - Data Entry / Maintenance Needs To Be Easy And Quick
 - Otherwise Leads To User Frustration
 - » Which Leads To Incomplete & Incorrect Data
 - Agility Allow For Quick Business Process Changes
 - Invest In Technology
 - Regularly Scheduled Meetings To Review Governance Plan





 - Showoff How Data Governance Led Directly To Increased Productivity, Customer Satisfaction, Increased Sales, Etc.
 - Quarterly Town Hall Meetings, Etc.
 - Set Benchmarks To Meet
 - Feature Data Quality Measurement Dashboards On Intranet To Show Benchmarks Met (Or Not Met)
 - Tie Performance Reviews To Meeting Benchmarks
 - Assign Data Quality Champions
 - At Each Site
 - Each Department
 - Each Team
 - Etc. Whatever Provides Best Coverage
